6.2.1. Additional Information

The attached Organogram of the college depicts the administration set up of the college and the institutional bodies that are responsible for creating and implementing the policies in an effective manner.

In governance of the college, the Governing Body is the apex decision making body. The Principal is the Member Secretary. The President and Secretary of the Teachers' Unit represent the teachers in the G.B. The Senior Assistant of the college represents the employee in the G.B. The Vice-principal of the College, the Librarian, Guardian's member, donor member, two number of affiliating university nominees are the other members of the G.B. The Local MLA is the permanent special invitee.

The College has a Teachers' Unit affiliated to Assam College Teachers Association. The College has also an Employees' Unit affiliated to the Assam Govt. Employees Association. The college has a Students' Union which takes important rules in implementation of college festivals and programmes.


For appointments, advertisements are published in at least two leading news dailies and in the college website. Accordingly interviews are conducted as per govt rules.

The College recommends promotion of its employee to the Director of Higher Education, Assam. Promotions of faculty-members are made according to the UGC rules/ Government of Assam rules, through DPCs held as and when necessary. API scores of concerned teachers are verified through IQAC before holding of the DPCs.

The College has its own policies on E-governance, Sustainable Policies (Green Policy, Policy on Environment and Energy Usage, Policy on Cleanliness), Gender Sensitization against Sexual Harassment, Inclusion of persons with disabilities, etc). The College prepared Perspective Plan for the period 2016-2021 taking into consideration future requirements of the college, while special emphasis was given to the recommendations of the NAAC during the last cycle of accreditation in 2015. The yearly strategic plans executed by the college are parts of the Perspective Plans. One of the key success of implementation of perspective Plan is the introduction of Science Stream in 2019 and B. Voc programmes in 2020. The implementations of all the Strategic Plans year wise are published as reports in college annual Newsletter.



According to the Census of India 2001 Report, there are 2.19 crore persons live in India with disabilities which is 2.13% of the whole population. Further, according to the same Census Report, fifty-one percent persons with disabilities are illiterate. Hence, there is an urgent need for mainstreaming these persons in the general education system through comprehensive education policies. The constitution of India also ensures equality, freedom, justice and dignity of all individuals and mandates a comprehensive society for all, including persons with disabilities. In the recent years, there have been immense changes in the society towards persons with disabilities. It has been realized that a majority of persons with disabilities can lead a better quality of life provided they have equal opportunities and efficient admittance to rehabilitation measures.





At college level the Governing Body is the apex body and Principal is the Drawing and Disbursing Authority. There are different committees under the leadership of Principal for overall management of the college. IQAC and Principal Office have reciprocal relation in terms of quality management. Effective functioning of these committees is visible from policies, procedures like service books, appointment and promotion system, code of conduct etc.

ADMINISTRATIVE SETUP

The College functions under the Department of Higher Education, Assam Govt. through the Director of Higher Education, Assam which rolls out policies and programs, and the Director is the appointing & disciplinary authority and prescribes govt. rules in academic-administrative-financial matters. 

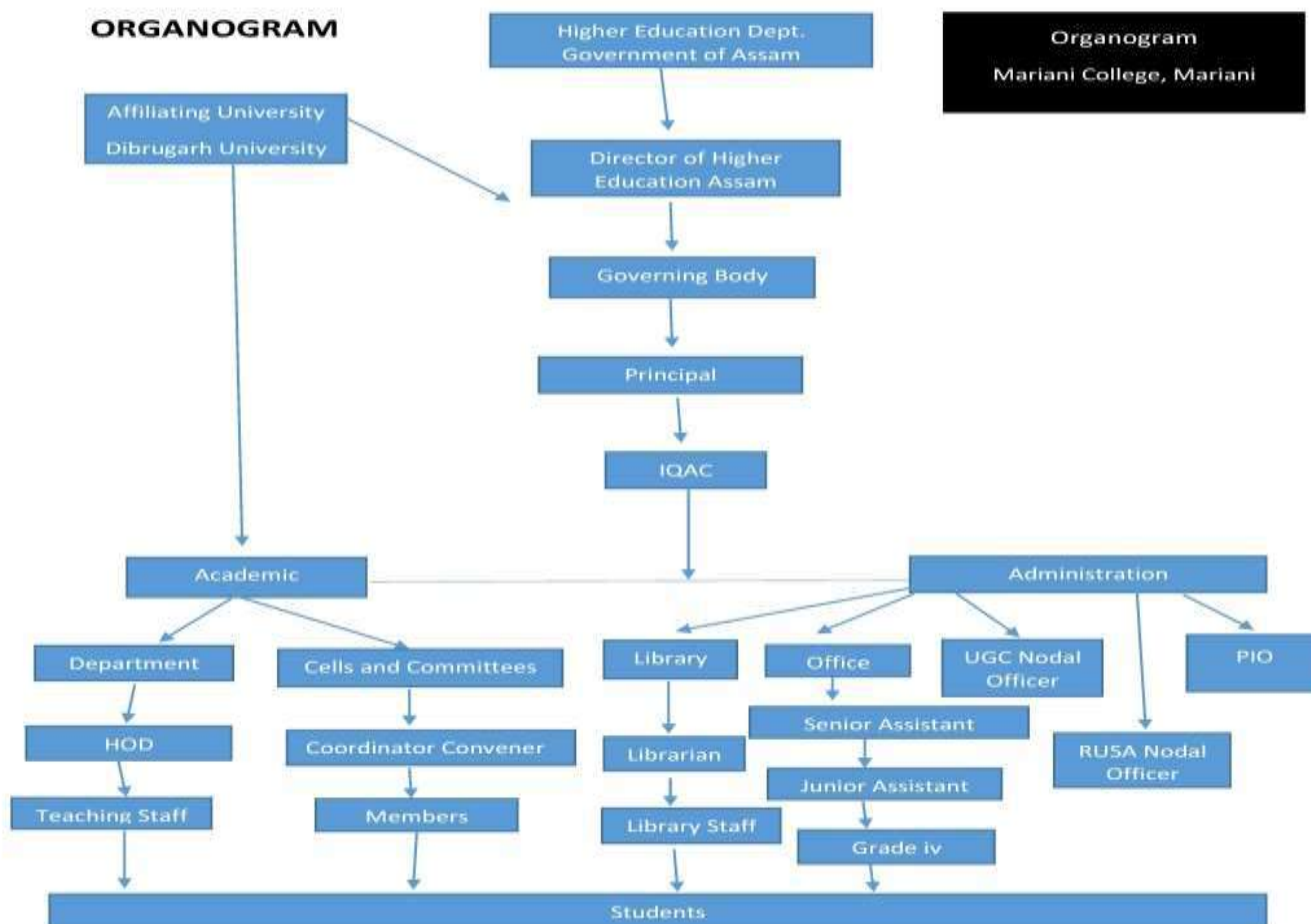
